- **For Legal Compliance**: We may share your information if required to do so by law, regulation, or legal process (such as a subpoena, court order, or government request).
- **Business Transfers**: In the event of a merger, acquisition, or sale of all or a portion of our business, your information may be transferred as part of the transaction.
- With Your Consent: We may share your information with third parties if you provide explicit consent to do so.
